Building Use Fees - General Use, Recitals, Events with Admission Fees

Miscellaneous Fees (applies to all rentals, including members)

Building Use Deposit \$50 Refundable upon successful inspection by staff
Cancellation Fee \$50 If canceled within 2 weeks of reserved date

Fee Waivers

The Board, or Minister, may use discretion to waive various rental fees for organizations or groups that align with the values of our church, and for whatever reason, have limited ability to pay for use of the space. Such occurrences will be noted in a standard rental agreement.
